

Terms and conditions for protocols developed by ICFRE institute

1. Plants/cultures will be dispatched with unique identity and for commercial use, the user agencies has to maintain the identity of the plants with institute's name.
2. Buyers will not have the rights to resell the live cultures; they will have the right to produce the plants from the cultures provided by different institutes.
3. Product transfer will be under IPR management policy of ICFRE.
4. All legal liabilities will be dealt within the jurisdiction of the institute.
